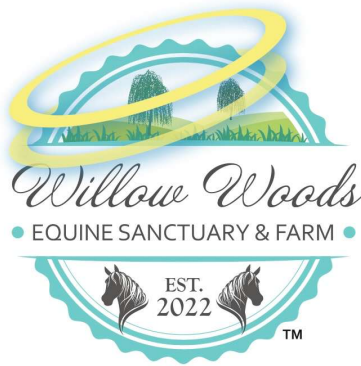
In consideration of being allowed to participate in the horseback riding lessons/trail rides at Willow Woods Equine Sanctuary.

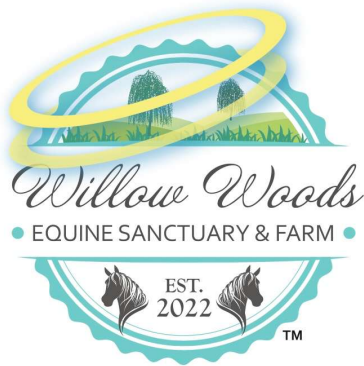
